Meals on Wheels of the Monterey Peninsula (MOWMP) serves all areas of the Monterey Peninsula and areas in the Salinas Valley and throughout broader Monterey County. For 2024-25, MOWMP served over 1,100 homebound seniors with 474,664 meals, daily safety checks and friendly visits from more than 600 trained volunteers. MOWMP clients report improved health, security, independence, and overall wellbeing. For millions of Americans, Meals on Wheels' programs are the difference between remaining in their own homes and needing to relocate to a skilled care facility. The nutritious meals, friendly visits, and safety checks help clients cope with three of the biggest threats of aging: hunger, isolation, and loss of independence. Research proves that when seniors have adequate nutritional and social support, they gain a greater quality of life, need fewer hospital stays and live longer.
